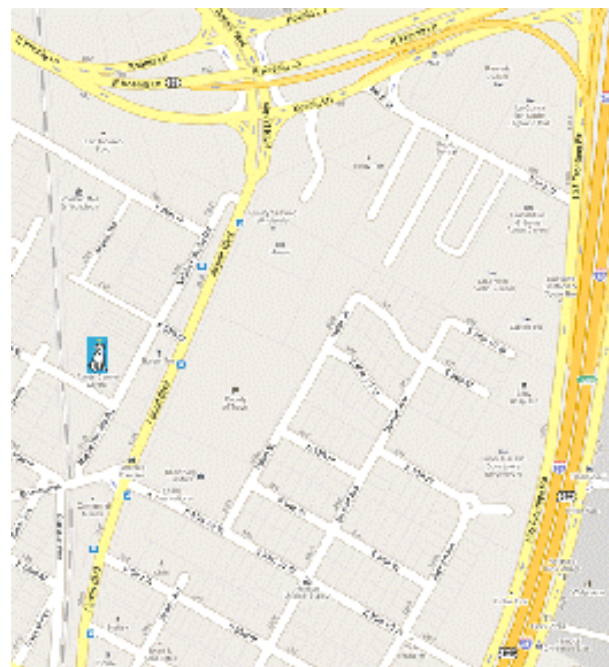
From Hwy 290 West:
