Entry fees for bitches in season will be refunded if a veterinarian's certificate is presented to the Trial Secretary before noon October 17, 2007. Exhibitors are responsible for complete, accurate and legible information on their entry forms; illegible or incomplete entries will not be accepted. Entry fees will not be refunded in the event that a dog is unable to compete, absent, disqualified, excused or barred from competition by action of the trial committee.



Driving from NORTH or SOUTH, take Interstate 35 to Georgetown, Texas. From the NORTH, take exit 262 for RM 2338/Lake Georgetown, go to the first light, and turn LEFT to cross over I-35 onto Williams Dr. (From the SOUTH, take exit 261A for RM 2338/Lake Georgetown, go to the first light, and turn RIGHT onto Williams Dr.) After one block, turn left at the light onto Austin Ave. ('T' intersection).
